10:00-10:30: Welcome speech from Peter Losonczi VSBM).

Dr. Endre Dobos (UM), the project leader gave a brief introduction on the aim of the meeting: The main aim of the meeting is to discuss the process of the ongoing activities that must be completed in this reporting period and all the relevant tasks.

The ongoing activities are:

-Act6: Disaster medicine protocol development

-Act7: Environmental Impact Assessment study development

10:30-12:30: Detailed discussion of the ACT6 Disaster medicine protocol related tasks.

The participants of the meeting discussed the content of the disaster medicine protocol study. There will be 2 documents developed, one in Hungarian and another in Slovakian language. The content of the documents will be harmonized, covering the whole catchment. The SK version will have more emphasize on the Slovakian side, the HU version will focus on the Hungarian side of the catchment area.

The chapters of this document will be the following:

- chapter 1: the goal of the protocol: the content will be the same on both sides
- chapter 2: legal background: the content will be a list of relevant laws, describing the legal background
- chapter 3: health care system: medical infrastructure (hospitals, etc.)
- chapter 4: social care system: list of accessible social institutes: elderly homes, institutions for disabled person, all the object that can be used in case of flooding.
- chapter 5: levels of health care management: local system, content of crisis management regulation, answering the question who has to do what?
- chapter 6: CSCATTT: internet protocol, basics of actions has to be done in case of flooding, common content thast will be compiled by the Holocen.
- chapter 7: command and control: international and cross sectoral systems,
- chapters 8-13: these are the most important elements of the protocol. Holocen will copile them, and these will be sent to TUKE for SK expert review.
- chapter 14: alarm and confinement: descriptions of pre activites (eg. how to call back doctors in risk of flood) only alarm to be ready to act for managing the flood situation.
- chapter 15: plans for maintaining: material supply to medical centers, if the hospital is flooded, how it can be moved to a safe position.
- chapters 16-17: evacuation rescue plan: targeting only the medical infrastructure
- chapter 18: this chapter is not needed, it is relevant only in case of nuclear accidents.
- chapter 19: moving medical post: description of vehicles can be used as moving hospitals, medical tents.

TUKE has a medical expert who is working with rescue systems, she will review the document and add her comments. TUKE will send the Slovakian chapters to Holocen to make it a common joint document.

12:30-14:00 Detailed discussion of the ACT7 EIA study

The development of EIA study is going smoothly, similarly to the DMP, the consortium will create 2 documents, one in Hungarian and another in Slovakian language. The content of the documents will be harmonized, covering the whole catchment. The SK version will have more emphasize on the Slovakian side, the HU version will focus on the Hungarian side of the catchment area.

The effects of climate change, extreme weather events, flash floods will be taken into consideration.

TUKE will create a short (~2 pages) summary in English.

Deadline for completion of the SK, HU versions: 20th of June. Then the documents will be harmonized and completed with the other side's description.
